- II. There were no previous meeting minutes to approve.
- III. Lisa Green welcomed all in attendance and started the meeting by introducing DELAC Vice President, Guadalupe Mendieta, and Administrative Director of Accountability and Special Programs, Cyndi Paik.
- IV. Cyndi Paik explained at length and in depth the Title I OUSD Parent Involvement Policy and Parent Notification. The policy as it pertains to Title I and non-Title I schools was highlighted and discussed. Those in attendance also received a copy of the OUSD Parent Involvement Board Policy 6020. Cyndi Paik also explained the Parent Notification as it pertained to Program Improvement Schools and the Orange Unified School District. The Local Control Funding Formula was discussed, as well as SES Tutoring. Cyndi Paik also led a discussion with those in attendance about the new Common Core State Standards, 21<sup>st</sup> Century Skills, and technology. Parents expressed their opinions and thoughts.
