- I. The call to Order. Eva Coria called the meeting at 9:03 AM.
- II. Opening Ceremony. Elizabeth Anguiano led the Pledge of Allegiance.
- III. Approval of minutes. Norma Leal asked to review the September's minute. The first approval motion was done by Sonia Ramirez, and the second one by Erika Salgado. The minutes were approved without changes.
- IV. OUSD College and Career Night. Dina Davis invited the audience to attend the event to learn about the programs and career opportunities, meet with representatives from Colleges and Universities, such as Santiago Canyon College and attend breakout sessions on College Athletics, admissions, and planning for College, career, and life success. The place is El Modena High School on 10/23/17 at 5:30 PM for site parents, and 6:00 PM for general public.
- V. Local Control Funding Formula (LCFF), Title I Program Improvement. Sandy Shaffer explained that under **No Child Left Behind** (NCLB 2001), the term Program Improvement described underachieving schools that had Supplemental Education Services (SES) to help them increase the achievement of students with federal funding for afterschool tutoring through outside agencies; also, the school of choice including transportation was available. When **Every Student Succeeds Act** (ESSA 2015) took place instead of NCLB, the term Program Improvement is discontinued, additional funding is provided to schools Title I base on their enrollment (afterschool tutoring, technology, software as Lexia), SES is retired, students enrolled under NCLB can stay until the highest grade existing on the recipient school.
- VI. OUSD Master Plan for English Language Learners, Waiver Request. Amber Tatch reminded us that in order to enrolled at OUSD • it is required to fill the Home Language Survey (HLS) which has four questions related to EL (English Learner) profile • if assessment is detected it is required to take the CELDT (California English Language Development Test) which determines if a student is an EL. She also talked about the Parental Exemption Waiver Request which under proposition 58 enables students to have instruction in their primary language thru the dual immersion programs available (Mandarin and Spanish) instead of the traditional EL program, for groups of minimum of 20 students.
- VII. District Goals and Program Objectives. Amber Tatch explained that this year the State Government will determine reclassification using the CELDT exam. All students will be taken ELPAC exam, and those who are profiled to be reclassified will take also the CELDT exam. The California School Dashboard is the new accountability system, replacing the prior Annual Measurable Objectives (AMAOs) part of the NCLB. The new accountability system considers several aspects of the EL growth per year, moving through colors from less to more improvement, from red, orange, yellow, green until blue. She explained the Formula of the English Learner Progress Indicator (ELPI), which measures the percentage of EL students advancing in proficiency (increasing one CELDT level or maintaining the early advance/advance level) during the school year and those reclassified the previous year. The reclassification goal for all sites is 15%, and for Long Term English Learners (LTEL) is 5%.

- VIII. Know your Benefits. Joe Alvarez explained that ●income and members of the household are primordial to the applications Medi-Cal, Covered California, Kaiser Child Health Plan, CalFresh, CalWorks. He recommended ●to search for a doctor belonging to a Hospital and Specialists networks that fit your needs, ●provide all the information required. He talked about ●the SB4 which includes children until 18 years old, regardless the migratory status, ●for people 19 and up, the legal status is required, ●people without Health Insurance will get a fine. He also talked about the ●importance of keeping communication with your social worker the first 90 days, ●keep on hand the emergency contact information about your doctor and hospital. He said the ●Mental Health under Obamacare is included in all Cover California plans, followed by Medical adopting the state rules, but the conditions vary depending on the provider, District, age, etc. ●Medical and Cover California had ten basic services, Private Health Services have 4 or 5. He mention that ●is expected an increase of 3.5% on Health Insurance for California, ●the impact of using Emergency Services, ●there is co-payment for Cover California or Private, Medical is by premiums, ●Medical offers 30% off on gas and electricity services thru Care Program. The counseling services are free. (www.chioc.org).
- IX. Parent Engagement Institute for the fall. Abril invited the attendees to the three sessions about Inter Safety, Cyberbullying and Bullying Prevention Internet Security taking place on October and November, the schedule is 6 PM to 7:30 PM.
- X. Local Control Accountability Plan (LCAP), survey information and take. Abril Ceja invited everyone to take the LCAP survey after the meeting, and explained how this survey is base to the EL funds allocation.
- XI. Questions and Comments. There was a raffle to thank the attendees, and there was a special recognition to the Jordan's moms that brought an excellent breakfast.
- XII. Closure. Abril Ceja thanked everyone for their attendance. There were no closure motions. The meeting closed at 11:01 AM.
