Aside from being a college professor, I have served as an expert witness to Superior Courts in Orange and San Bernardino County for the past 30 years, evaluating criminal defendants (adults and juveniles), in cases where their mental status is one of the issues being adjudicated.

4. Why do you want to be a school board member?

Gratitude for the benefits my family has received from having our children (now young adults) going through the OUSD. I also feel like I am at a stage of life when I have a civic duty to give back to the community where I live.

5. What do you see as the basic purpose of the public schools?

They are the principal, public institution responsible for helping our children become educated, responsible citizens. More specifically, they are the main training grounds for helping our children prepare for the next phase in their lives; college and / or the workforce.

6. What is the role of the school board in the fulfillment of that purpose?

I cannot claim I am fully informed on this, but as an informed citizen, it seems that the Board takes on the advisory role of overseeing the broad interests of all children in the District. It appears from my perch that the Board gets involved at the macro-level, mainly with resource allocation and personnel matters.

7. How does the board's role differ from that of the superintendent?

Again, I am probably not the most informed on this, but I am sure there is overlap in roles and responsibilities. As the chief district administrator, I am assuming the Superintendent is involved more with the more day-to-day decision-making, particularly at a school level and management of District affairs, while the Board takes the broader, longer-term perspective on issues affecting the District, as a whole.

8. What should be the relationship between the board members and the administration in the handling of school concerns?

Given that they share the same ultimate goals and underlying responsibilities to care after our children's educational well-being, I would expect that the relationships between these individuals is going to be collegial and marked by mutual respect.

9. Briefly describe your commitment to public education and our school district.

My family has lived within the OUSD for the past 20 years. We have had two children go through Villa Park High School, and now have two in college preparing to become teachers. My wife has been working as a teacher for OUSD for a number of years, currently as a kindergarten teacher in an inclusion classroom at Fairhaven Elementary School.

10. What do you see as the strengths of the school district?

From the perspective of a parent, what I have observed and experienced is a great number of excellent, engaged and helpful teachers, administrators and staff. My family has benefitted for the many OUSD employees who have personally helped our children, and am confident this has extended throughout the District.

11. What do you see as the area(s) most needing improvement in the school district?

Again, I am less than fully informed about this. Through reading and general discussion with other parents, I know that upgrading aging facilities and inclusion of all students in the general, educational enterprise are ongoing issues. I have a tremendous amount to learn in this regard, and expect to do so; regardless of the outcome of my application.

I previously served as a legislative liaison between a member of the California State Assembly and the Orange Unified School District Legislative Coalition. - 4. Why do you want to be a school board member?

  As an OUSD alumnus who has made my career in public policy, I bring a unique perspective and experience that can help the school board and the district navigate state government and work with other local governments. I want to ensure my future children have the same strong educational foundation I had in OUSD before going on to Stanford.
- 5. What do you see as the basic purpose of the public schools?

  Public schools are responsible for providing a free education to all students residing within the local attendance area. Public schools need to ensure that every student achieves grade-level proficiency in all subject areas. Public high schools must also ensure that their students are ready for college or the workforce when they graduate.
- 6. What is the role of the school board in the fulfillment of that purpose?

  The school board needs to set high educational standards, within the confines of federal and state law, while ensuring teachers, administrators, and classified school staff have the necessary resources to provide all students with a safe, productive learning environment.
- 7. How does the board's role differ from that of the superintendent?

  The school board is a policymaking and oversight body that also serves as a link for the community to the school district. The superintendent is a professional executive who is responsible for running the school district within the policies set by the school board. In effect, the school board is a legislative body while the superintendent is an executive.
