3. Review/Approve SPSA Implementation Title I Budget Update – Review Spending to Date- Mr. Uriostegui

Mr. Uriostegui reviewed feedback given by the district in regards to Orange High’s SPSA. Mr. Uriostegui reviewed with the council teacher PLC time requests. Mr. Uriostegui recommended to the council to have funds transferred from Equipment to teacher x-tra earnings /staff development and substitutes in order to be able to pay teachers for PLC meetings. Glenna Buttrey motioned to move \$17,000 to be transferred to teacher extra earnings /staff development and \$5,000 to substitutes from Equipment in order to have teachers meet in PLCs.
